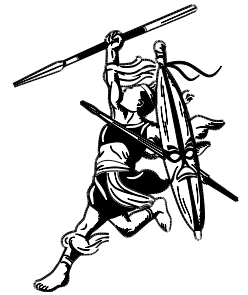

1) Cost of participation for solo artists

The total costs for individual artists participating in one of the two ARTMUC editions or the INC art fair 2026 are as follows (plus 19% VAT):

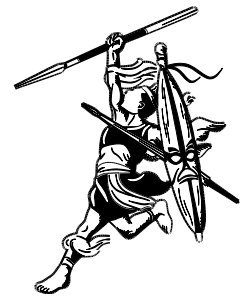
If a wall length is booked jointly by several artists, the 'services per exhibition space' - e.g. the number of issued exhibitor passes, free tickets, etc. - will be divided equally among the number of artists.

2) Confirmation and invoicing

a) Acceptance to ARTMUC May 2026

If accepted by the jury, participants will receive the binding contract together with their confirmation of participation for the ARTMUC event in May, along with an invoice for the total amount of the fees. The contract must be signed and returned to the organizer within two weeks of receipt, and the participation fee must be transferred.

The corresponding invoice must be transferred to the organizer within the period specified on the invoice.

b) Confirmation for ARTMUC October 2026 & INC art fair Bodensee November 2026

In the event of approval by the jury for the ARTMUC edition in October 2026 and the INC art fair Bodensee in November 2026, participants will receive, together with their confirmation of participation, a binding contract and an invoice for the reservation of participation in the amount of €350.00 net (plus 19% VAT). The contract must be signed and returned to the organizer within two weeks of receipt, and the invoice for participant support must be transferred to the organizer within the period specified in the invoice.

The total invoice for the complete participation fees will be sent approximately 8 weeks before the events and must be paid within 2 weeks. The portion of the participation fees already paid will be deducted from the total invoice.

In the event of cancellation, regardless of when the participant cancels, the amount of €350.00 net (plus 19% VAT) charged in the first invoice for participant support will not be refunded.
